3- RULES AND REGULATIONS OF THE TRUST -

1. The Trustees shall manage the subject matter of the Trust economically and with circumspection as they may jointly at a meeting or by circulation resolve upon. If any vacancy arises in the Board of Trustees its chairman shall nominate and appoint any suitable person as Trustee in the vacancy or vacancies so arising so that the Board of Trustees always be not less than seven. The Trustees may co-opt one or two more Trustees to make the strength or the Board nine, of they so desire.
2. Any question arising in the administration of the Trust shall be decided by the majority of the

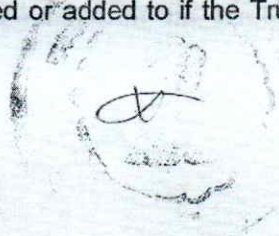

Trustees acting for the time being. In case of tie the chairman shall have a casting vote.

3. To invest disposal or transfer and otherwise deal with the subject matter at the Trust in such manner as the Trustees shall deem fit so as to enable them to carry out the objects of the Trust.
4. To open account in the name of Trust/Trustees and/or other financial institutions run/conduct by the Trust with a Bank or Banks to operate such accounts and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.
5. Any long as the DONOR shall live and be able to act in the matter, he shall remain one of the Trustees and shall function as Chairman and Managing Trustee and shall be entitled to preside over all the meetings of the Trustees and of this Trust unless prevented to do so by any rule of law. The Chairman will have the right and power to choose and select the future Chairman. The post of the chairman shall vest to the kin or family members of the chairman, Ainul Haque. Therefore the Managing Trustees for the time being shall have and exercise all the afore mentioned functions. To represent the matters in courts and other purposes the Chairman shall represent the educational and welfare trust.
6. The Trustees may frame rules and regulations necessary and conducive to the proper and smooth conduct, working and management of the Trust. The rules and regulations so framed may at any time be amended or added to if the Trustees

7. In all other matter, not specifically provided for herein the Trustees shall function in accordance with the provisions of the Indian Trust Act by passing resolutions.
8. Director/Principal may also be appointed from the list of trustees if qualified and will be paid accordingly for that services.
9. The members of the Trust will constitute as Governing Body of the Institution/Institutions where as the Chairman of the Trust acts as the Secretary of the Institutions.
10. The Trustees shall keep proper accounts showing all receipts and disbursements made on account of the Trust hereby constitute and a Chartered Accountant shall duly audit the same once in every year as Trust appointed.
11. The Board of Trustees shall be entitled to appoint from time to time Staffs, Professionals, Technical, Non-Technical, Trainers and etc. with such powers and duties and upon such terms as to duration of office remuneration or otherwise and at any time suspend, dismiss, terminate or discharge any or such of them as the Board of Trustees shall think proper.
12. The Trust shall be entitled to borrow loans from any State Government or Central Government Nationalised or Scheduled Banks or any Financial Institutions or Non-Government Financial Institutions, any abroad agencies/institutions and etc. and disburse of the same for the purpose of education.


